

Last Will and Testament

OF

I, _____, a resident of the County of _____, State of California, declare this to be my Will.

FIRST: I revoke all Wills and Codicils heretofore made by me.

SECOND: I declare that I am _____ (married/unmarried).

THIRD: I give, devise, and bequeath all of my estate, of whatsoever kind and wheresoever situate, to _____, if he/she survives me.

FOURTH: I hereby nominate and appoint _____ as Executor of this Will, to serve without bond.

If _____ is unable or unwilling to serve as Executor, in that event, I nominate _____ as Executor, to serve without bond.

FIFTH: I authorize my Executor to sell, with or without notice, at either public or private sale, and to lease any property belonging to my estate, subject only to such confirmation of court as may be required by law.

SIXTH: I direct that all inheritance, estate, or other death taxes that may by reason of my death be attributable to my probate estate or any portion of it, or to any property or transfers of property outside my probate estate, shall be paid by my Executor out of the residue of my estate, disposed of by this Will, without adjustment among the residuary beneficiaries of my probate estate, or from any transferee or beneficiary of any property outside my probate estate.

SEVENTH: Except as otherwise provided in this Will, I have intentionally and with full knowledge omitted to provide for my heirs. If any person who, if I died intestate, would be entitled to any part of my estate, shall either directly or indirectly, alone or in

conjunction with any other person, claim in spite of my Will and intestate share of my estate, I give that person One Dollar (\$1.00) and no more, in lieu of any other share or interest in my estate.

If any beneficiary under this Will in any manner, directly or indirectly, contests this Will or any of its provisions in any legal proceeding that is designed to thwart my wishes as expressed in this Will, any share or interest in my estate given to that contesting beneficiary under this Will is revoked and shall be disposed of in the same manner provided herein as if that contesting beneficiary had predeceased me without issue.

EIGHTH: I have not entered into a contract to make Wills or a contract not to revoke Wills.
